**Type of sale** - The sale is a non-judicial deed of trust lien and security interest foreclosure sale being conducted pursuant to the power of the sale granted by the deed of trust executed by NANDAKUMAR KUMAR AND BRINDA CHINNNADURAI, HUSBAND AND WIFE. 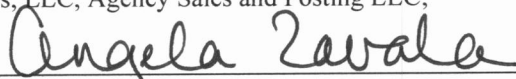
