2. **Terms of Sale.** The sale will be conducted as a public auction to the highest bidder for cash. Pursuant to the deed of trust, the mortgagee has the right to direct the Trustee to sell the property in one or more parcels and/or to sell all or only part of the property. Pursuant to section 50.009 of the Texas Property Code, the property will be sold in AS IS, WHERE IS condition, without any express or implied warranties, except as to the warranties of title, if any, provided for under the deed of trust.

3. **Instrument to be Foreclosed.** The instrument to be foreclosed is the Deed of Trust or Contract Lien dated March 9, 2022 and recorded as Instrument Number 2022034300, real property records of Williamson County, Texas.

4. **Obligations Secured.** Deed of Trust or Contract Lien executed by MATTHEW ORLANDO DALEY AND SAMANTHA ANDREA KATSOUNAS, securing the payment of the indebtedness in the original principal amount of \$935,000.00, and obligations therein described including but not limited to the promissory note; and all modifications renewals and extensions of the promissory note.
